## *Pastor's Message*

Valentine's Day, a day dedicated to celebrating love, often highlights the contrast between human love and divine love. While Valentine's Day is a beautiful opportunity to express affection and appreciation for our loved ones, it also serves as a reminder of the fickle nature of human love. Relationships can be marked by highs and lows, influenced by emotions and the circumstances of life. In contrast, God's love is steadfast and unwavering. It is not contingent on our actions or emotions but is rooted in his unchanging nature.



In the book of Revelation, chapter 2, verses 4-5, lies a poignant message that transcends time and speaks directly to the human heart: "Yet I hold this against you: You have forsaken the love you had at first. Consider how far you have fallen! Repent and do the things you did at first. If you do not repent, I will come to you and remove your lampstand from its place."

These verses, penned by the apostle John under divine inspiration, were addressed to the church in Ephesus, but their significance extends far beyond a single congregation. They serve as a reminder to all believers, throughout the ages, to remember their first love—a fervent, unwavering love for their Creator.

In a world filled with distractions, responsibilities, and trials, it's easy to lose sight of our passion for God and his salvation plan. The cares of life can gradually erode our spiritual fervor, leaving us with a sense of spiritual apathy or complacency. We may still go through the motions of religious duties, attending church services, and engaging in various ministries, but our hearts may have drifted away from the intimate relationship we once enjoyed with God.

But why is it so crucial to remember our first love? Why does God place such emphasis on this aspect of our spiritual journey? The answer lies in the nature of our relationship with him.

Our relationship with God is not meant to be a mere transactional exchange, where we fulfill religious obligations in exchange for blessings or divine favor. It is intended to be a deeply intimate and personal connection, characterized by love, trust, and unity. And just like any relationship, it requires nurturing, attention, and genuine affection to flourish.

When we first come to faith, we are often filled with a sense of awe and wonder at the grace and mercy of God. We are overwhelmed by his love for us, and our hearts overflow with gratitude and adoration. In those moments, our love for God is pure, unblemished by doubt or skepticism, and we eagerly seek to know him more deeply.

But over time, the busyness of life can chip away at that fervent love. We become preoccupied with our own concerns, our focus shifting from God to ourselves. Our prayers become rote and mechanical, our worship routine and disconnected from our hearts. The fire that once burned brightly in our hearts begins to flicker and fade.

Yet, the call to remember our first love is not just a condemnation. It's also an invitation—to return to the source of our joy and fulfillment, to rekindle the flame of passion that once burned within us. It is an opportunity to realign our priorities, to refocus our gaze on the One who loved us first and loves us still.

So how do we remember our first love? The passage in Revelation offers a simple yet profound prescription: "Repent and do the things you did at first."

First, we must repent. We must acknowledge any areas of sin or rebellion that have caused us to stray from God's love. We must humbly confess our shortcomings and ask for his forgiveness, confident that he is "faithful and just and will forgive us our sins and purify us from all unrighteousness" (1 John 1:9).

Second, we must return to the "things we did at first". We must recommit ourselves to the disciplines of prayer, worship, and the study of God's Word. We pray that the Holy Spirit would reignite a passion and zeal within us, empowering us to live lives that glorify and honor God, to love him with all our heart, soul, mind, and strength.

May we heed this call with humility and obedience, that our love for God may burn brightly once again, shining as a beacon of hope and grace in a world desperately in need of his love.

# Council Meeting Minutes

## February 7, 2024

### Elder's Report

Presentation on safety awareness by Will B. and the committee. They have done a really great job with this.

Communion help has been discussed due to having trouble getting enough councilmen to help at times. (Not everyone feels comfortable with this.) Recent council members who are willing will also be able to help.

### Principal's Report

Mrs. Panzer has accepted her full time call here at St. Paul's to teach 4th Grade.

Mr. Johnson is serving as intervention specialist and this position will not be funded next year.

Options would be to continue to make part time calls or issue a full time call as Mr. Johnson is doing full time work.

### School Board Report

Looking for approval to go from a 9 month tuition payment to a 10 month payment plan.

Motion to change the 9 month payment plan to a 10 month payment plan with payments starting in August, Motion carried.

Before or Aftercare to be reduced to 50% of the normal rate per hour if an aide has a child attending and they are helping.

Motion to reduce the hourly after and before schoolcare would pay 50% of the full rate. Motion carried. This will begin for the 2024-2025 school year.

### Treasurer Report

Financial Results to Budget

Revenue

Offerings for the month of January (4 Sundays) totaled \$70,400 (averaging \$17,600 per week) down from December (5 Sundays & Christmas), which totaled \$94,100 (averaging \$18,800 per week and compared to last year January-2023 (4 Sundays) totaled \$62,400. Year to date, offerings are running \$37,100 under budget. Tuition on the other hand is running \$26,200 over budget. Overall, expenses are close to budget so far this year.

Special donations received in January were:

- We received an additional \$13,100 for Growing Forward.
- \$1,100 for the Memorial Fund
- \$750 for the School Fund
- \$700 for Faith for the Future.

### Expenses

Church Expenses are \$1,374 under budget. In January we changed to WELS VEBA for medical, life and disability insurance. While the premiums are higher than the former carrier, they are lower than if we had remained with that insurance company. By consolidating insurance with WELS VEBA, and discontinuing the separate Life and Disability insurance carrier, we should be very close to budget.

School expenses are running \$31,200 over budget due to more hours and higher wages for School Aides and extra Hot Lunch Helpers. We are seeing higher expenses for textbooks and supplies with the startup of school. The first three School Choice Audits were completed and billed so far this year resulting in higher cost than budget.

Property / shared expenses are running \$24,300 under budget. With the added school space, custodian wages are running higher than budget. We are still seeing lower utility costs so far. Property & Casualty insurance are under budget When insurance charges for the building expansion were quoted, they are much lower than budgeted.

Missions: Monthly payments to WELS and MLHS were made to budgeted amounts.

The Total Expenses including interest are \$23,600 under budget while revenue is \$4,500 under budget resulting in a Net Result of (\$61,300), compared to a planned (\$79,700) loss.

### Building Expansion:

At the end of December, outstanding pledges for Growing Forward stand at \$183,400.

A Principal payment of \$60,000 was paid in January on our loan at Oostburg bank. The balance now is at \$2,876,900.

Will be closing off openings at the top of the block wall and also around the steel pillars in the Harvest Gym. Still looking for a backup custodian. Playground restoration is still on schedule for this summer.

Had 17 in attendance for axe throwing, the next pi night is scheduled for March 14th.

# Annual Meeting Minutes

## January 21, 2024

### Treasurer

The financial results for calendar 2023 were presented. Offering revenue is running below budget but tuition and school choice revenue is above budget resulting in a \$39K shortfall in revenue. Expenses were \$23K below budget, Donations for WELS & MLHS were paid to the budget. School expenses were over budget with unbudgeted start up supplies for the pre-school and more aides needed for the higher enrollment. Church & property expenses were under budget. An additional \$593K of Growing Forward donations were received in 2023 to bring the total received to \$3.1 million. \$207K of pledges were outstanding as of 12/31/23. Debt to the Oostburg bank was at \$2.9 million.

A recap of the Growing Forward funds and the building cost summary as well as the major equipment in the expansion was also presented. Building costs totaled \$5.2 million and equipment was \$220K.

A thank you to the six fellow members that assist the treasurer with the financial records of the Church & School.
